## Connecticut Behavioral Health Partnership Agency Reports:

### Judicial Branch – Barbara Lanza (Jud)

Barbara Lanza (CSSD) reported that there were few Legislative Bill updates from the recent Session. On July 1, 2022 the Career Pathway Program for juveniles and adolescents will have a \$1 million expansion. Project Longevity will also begin on July 1, 2022. There will

be amendments for the next fiscal year that will affect the unit costs and fees for services for some of their contract. They are receiving a 4% increase for additional funding which is a first time increase in their annual cost budget.

### **Department of Social Services-Rod Winstead (DSS)**

Rod Winstead (DSS) welcomed and introduced Gui Woolston as the new CT Medicaid Director. His report is below.

Provide Funding for Domestic Violence Child and Family Advocates	1,440,000.00

Public Act 22-81 (Senate Bill 2) - AN ACT EXPANDING PRESCHOOL AND MENTAL AND BEHAVIORAL SERVICES FOR CHILDREN as amended by LCO # 5219. The public act contains the following sections that effect DSS:

Section 25 (d)(1) Not later than October 1, 2022, the Commissioner of Social Services shall provide Medicaid payments to an enrolled independent licensed behavioral health clinician in private practice for covered services performed by an associate licensed behavioral health clinician working within such associate clinician's scope of practice under the supervision of such independent clinician provided certain conditions are met. (*Effective July 1, 2022*)

## Public Act 22-47 (HB 5001) - AN ACT CONCERNING CHILDREN'S MENTAL HEALTH As Amended by LCO # 5592.

*Section 58* requires OHS, in consultation with the DSS and Insurance Commissioners, to study whether payment parity exists between providers of behavioral and mental health services in the private insurance market and in the HUSKY Health program. OHS shall submit an interim report to the Appropriations, Human Services, Insurance, and Public Health Committees by January 1, 2023, and a final report by January 1, 2024. (*Effective from Passage*)

*Section 59* requires DSS to implement a Medicaid reimbursement system to encourage collaboration between primary care providers and behavioral and mental health providers (*Effective July 1, 2022*). *Section 68* creates a 10-member child and adolescent psychiatry working group Public Health Emergency scheduled to end July 15<sup>th</sup> will be extended

The link for the annual data collection for the Enhanced Care clinics went out 06/07/22 and due back 07/15/22.

# **Department of Mental Health and Addiction Services-** Colleen Harrington (DMHAS)

Colleen Harrington reported that there is a \$3.3 million increase for Young Adult Services (YAS) for the case load of youth discharge and diversion. There were adjustments made for the 1115 Waiver for the SUD Demonstration project. Mobile crisis services for adults have been expanded for 24/7 accessibility and Young Adult Services have been expanded and 4% COLAs have been provided to non-profit providers.

### **Department of Children and Families** – Dr. Stephney Springer (DCF)

Dr. Stephney Springer reported that \$21 million have been budgeted for urgent crisis stabilization centers and \$8.6 million have directed to expand mobile crisis services statewide and 24/7. The Family First program has been expanded by \$1.1 million and providers have received COLAs.

### Department of Developmental Services- Tammy Venenga (DDS)

Tammy Venega reported that there were no BH bills for DDS action during this past Session. DDS will partner with community providers for access and support for kids with intellectual development which will include respite centers for kids in BH services program. There is an RFP open for a children's step-down unit for ages 8 to 21 years old. They are using ARPA dollars to support their programs such as expanding plans for high schoolers and giving tuition assistance.

# **State Department of Education**- Bryan Klimkiewicz, Special Education Director (CSDE)

Bryan Klimkiewicz announced that the new Special Education Webpage and documents will go into effect on July 1, 2022.

## **Committee Reports:**

## <u>Coordination of Care</u>: - Rep. Jonathan Steinberg, Co-Chair, Janine Sullivan-Wiley, Co-Chair, Kelly Phenix, Co-Chair, and Sabra Mayo, Co-Chair

Co-Chair Janine Sullivan-Wiley reported that at the May meeting, Jenn Searls gave a presentation on the Connecticut Information Exchange (CONNIE). There was also a quarterly update on Non-Emergency Medical Transportation given by Veyo. She welcomed Pat Cronin

(DSS) as newly selected to oversee Dental Health as Marty Milkovic is retiring (Congrats Marty!). She said that during the PHE, Connecticut remains one of the few states who have expanded tele-health via phone services thanks to the work of this committee. Tri-Chair Neva Caldwell reported that at their June meeting they will have a presentation on child BH service crisis initiatives.
