First Course: The Social Worker's Role in Oral Health

Christina

- 41 year old woman referred by dentist for non-compliance, frequent no shows.
- Assessment identified significant dental phobia, readiness to accept help, medical and behavioral health history, supporters and strengths.
- Interventions:
 - Match dentist with patient needs.
 - Step wise approach to office visit.
 - Worked with therapist to obtain pre-visit medication.
 - Developed visit plan for reducing anxiety before, during, after appointments.
 - Check ins at minimum every 30 days.
 - Positive reinforcement on small wins.
 - Developing a shared humor/sarcasm about her experience.
- Outcomes: Multiple extractions, fillings, and partial denture completed. Patient now in routine preventive dental care.

She may not have known it, but we have worked together through some of the darkest periods of my life and there were times when her monthly check-in calls were the most consistent thing happening for me..."

Perform a quick/basic oral health screening and assessment

Identify oral health related goals within the context of a social work treatment or service plan

Apply oral health interventions towards goal attainment. Examples in Motivational Interviewing, Incremental Change/Micro-Changes, role modeling (parenting environments) via social learning theory
