Those have been approved by the Behavioral Health Partnership Oversight Council. The Clinical Management Committee met on June 24, 2025, to review the attached ASD Level of Care Guideline for Family Adaptive Behavior Treatment services. As members of the Operations Committee, we would like to submit the attached for your review via e-mail possibly in lieu of a scheduled meeting. There is some time sensitivity, as we hope to get these in front of the Behavioral Health Partnership Oversight Council for their scheduled July 9 meeting.
