

Summary of Total PCMH Attributed Members, Total Members Attributed to a PCP, and Total HUSKY Membership


By Quarter Ending September 2016 through December 2019

Comparison of Total CHILD Members, Total CHILD Attributed Members and Total PCMH CHILD Attributed Members


By Quarter Ending September 2016 through December 2019

Comparison of Total ADULT Members, Total ADULT Attributed Members, and Total PCMH ADULT Attributed Members




