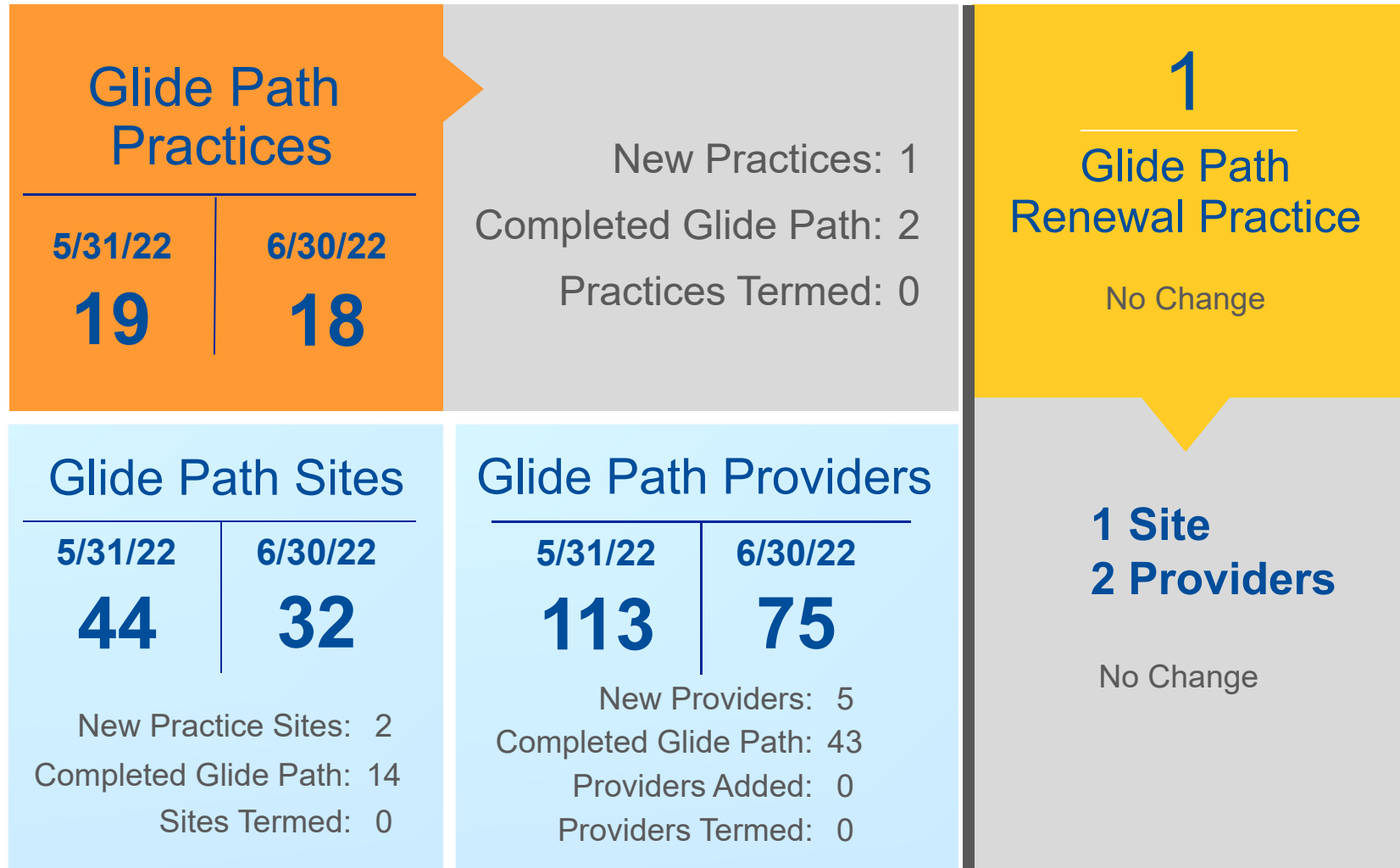

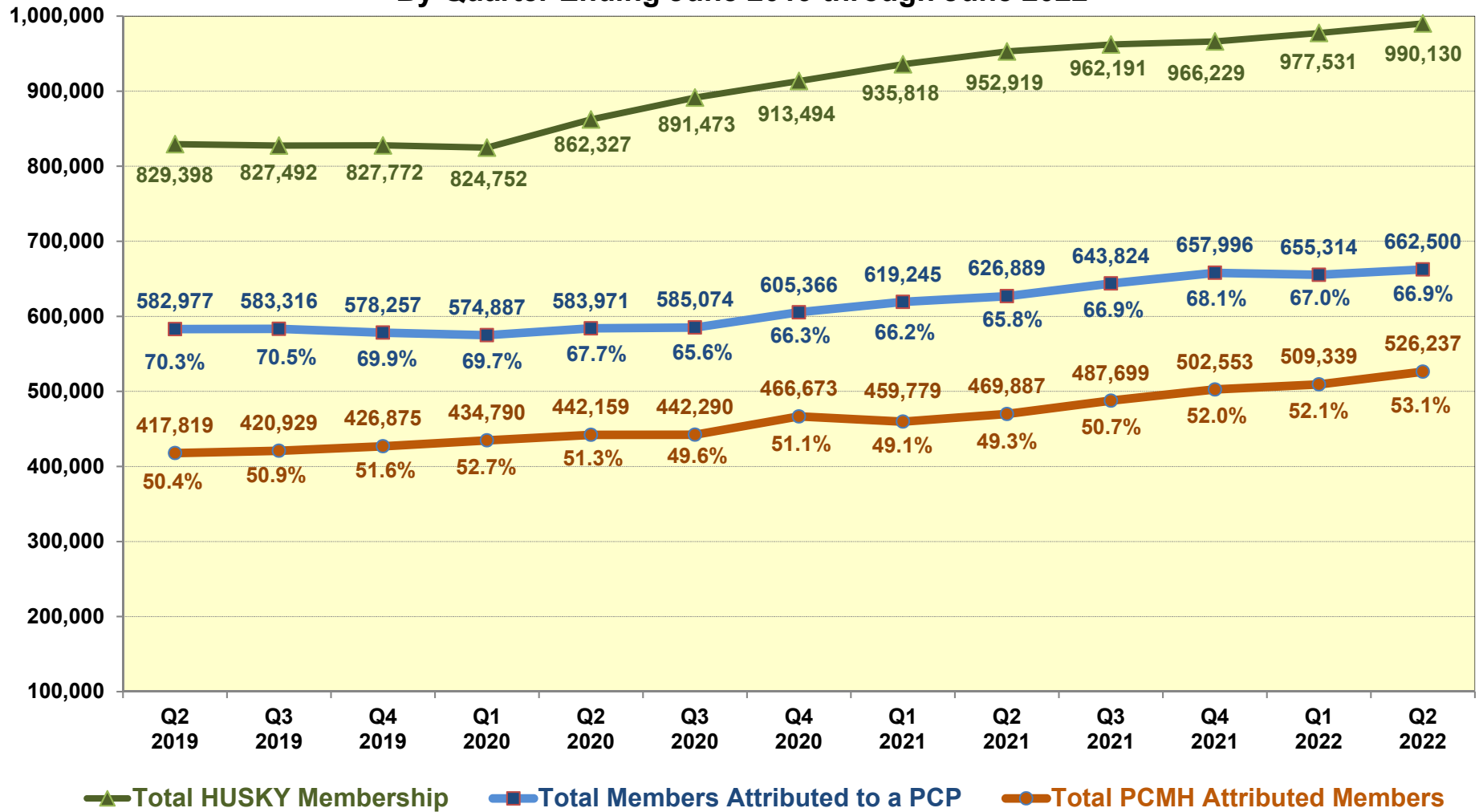

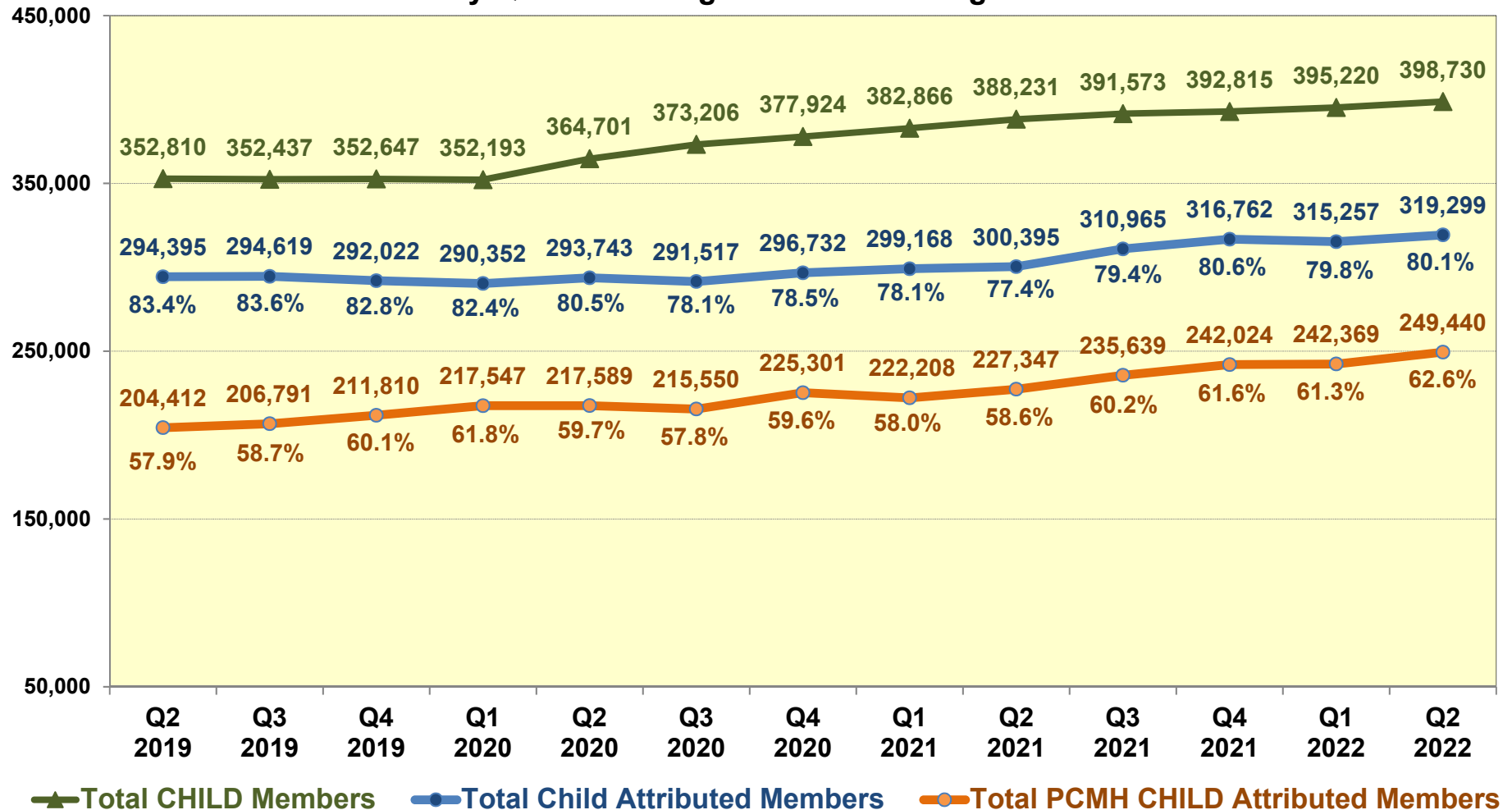

By Quarter Ending June 2019 through June 2022



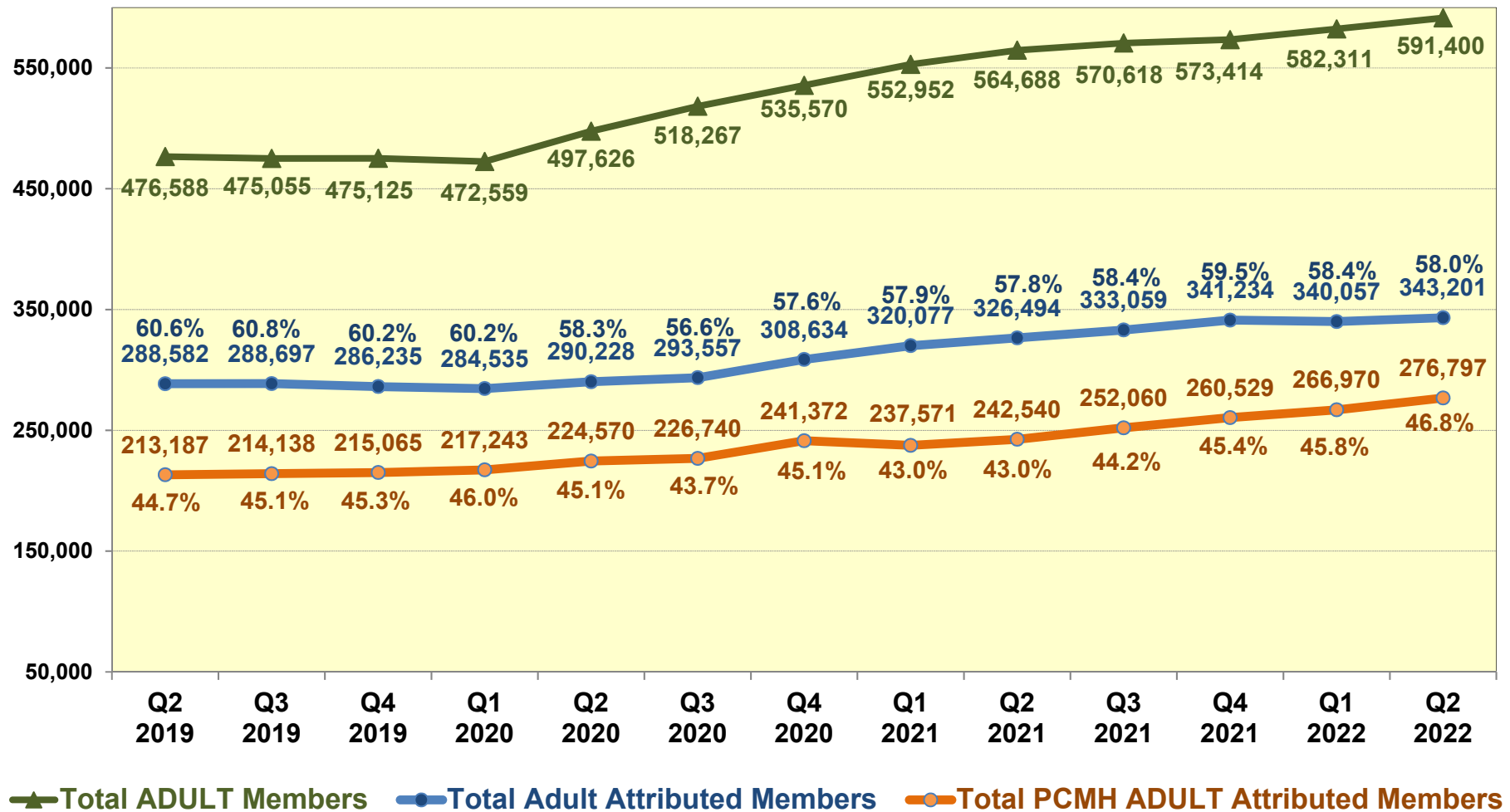
PCMH Program CHILD Member Attribution

By Quarter Ending June 2019 through June 2022

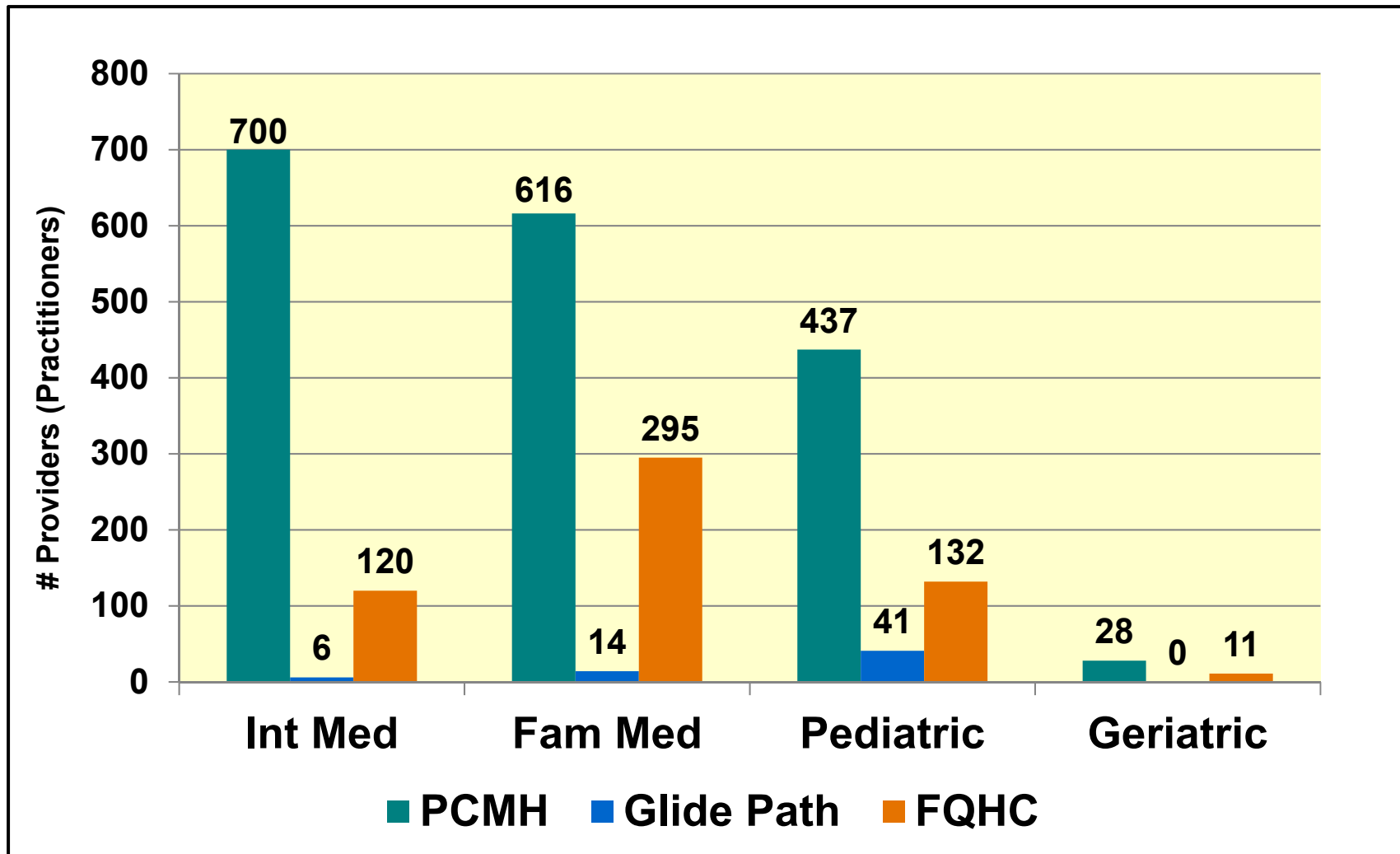


PCMH Program ADULT Member Attribution

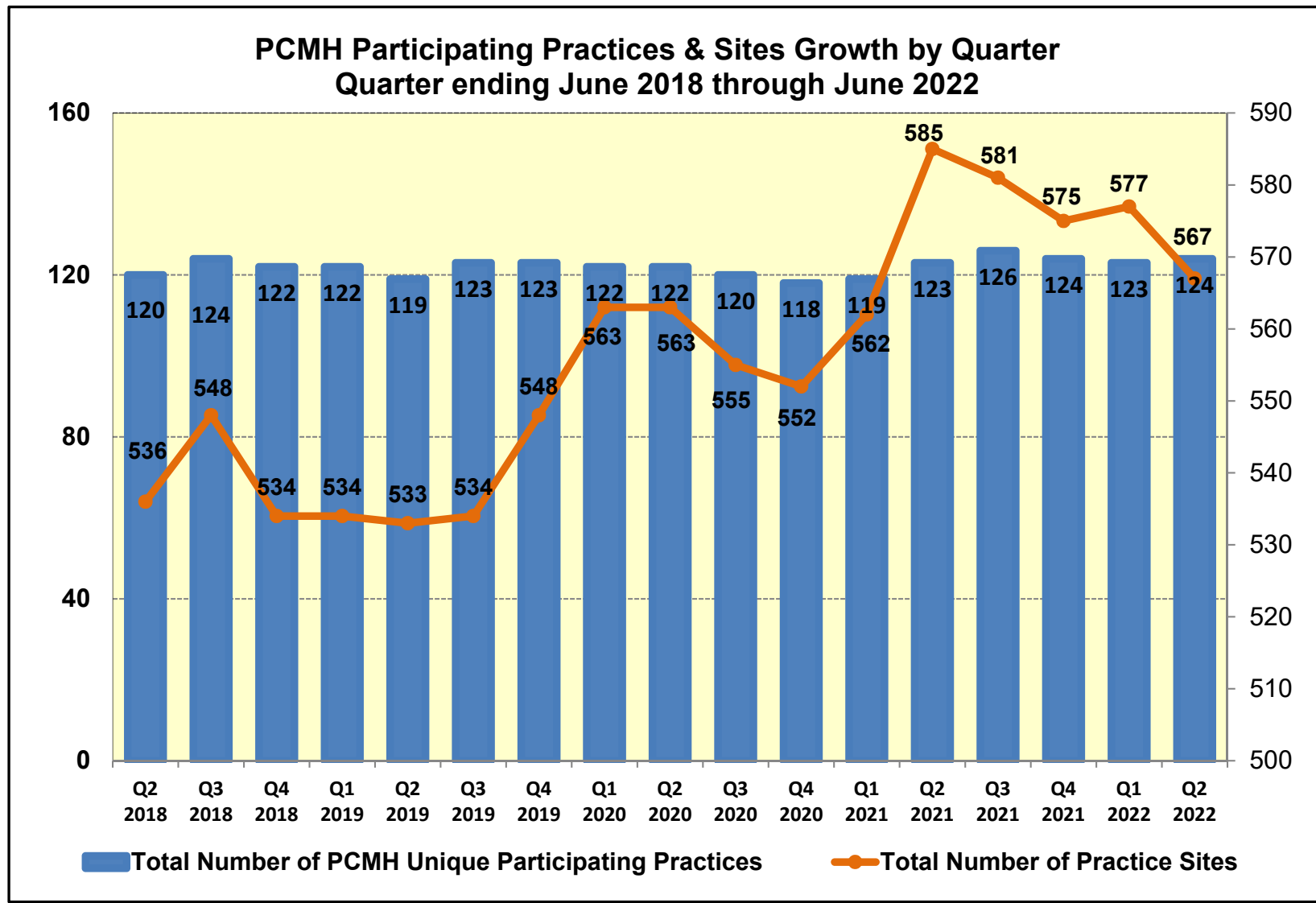
Comparison of Total ADULT Members, Total ADULT Attributed Members,

By Quarter Ending June 2019 through June 2022



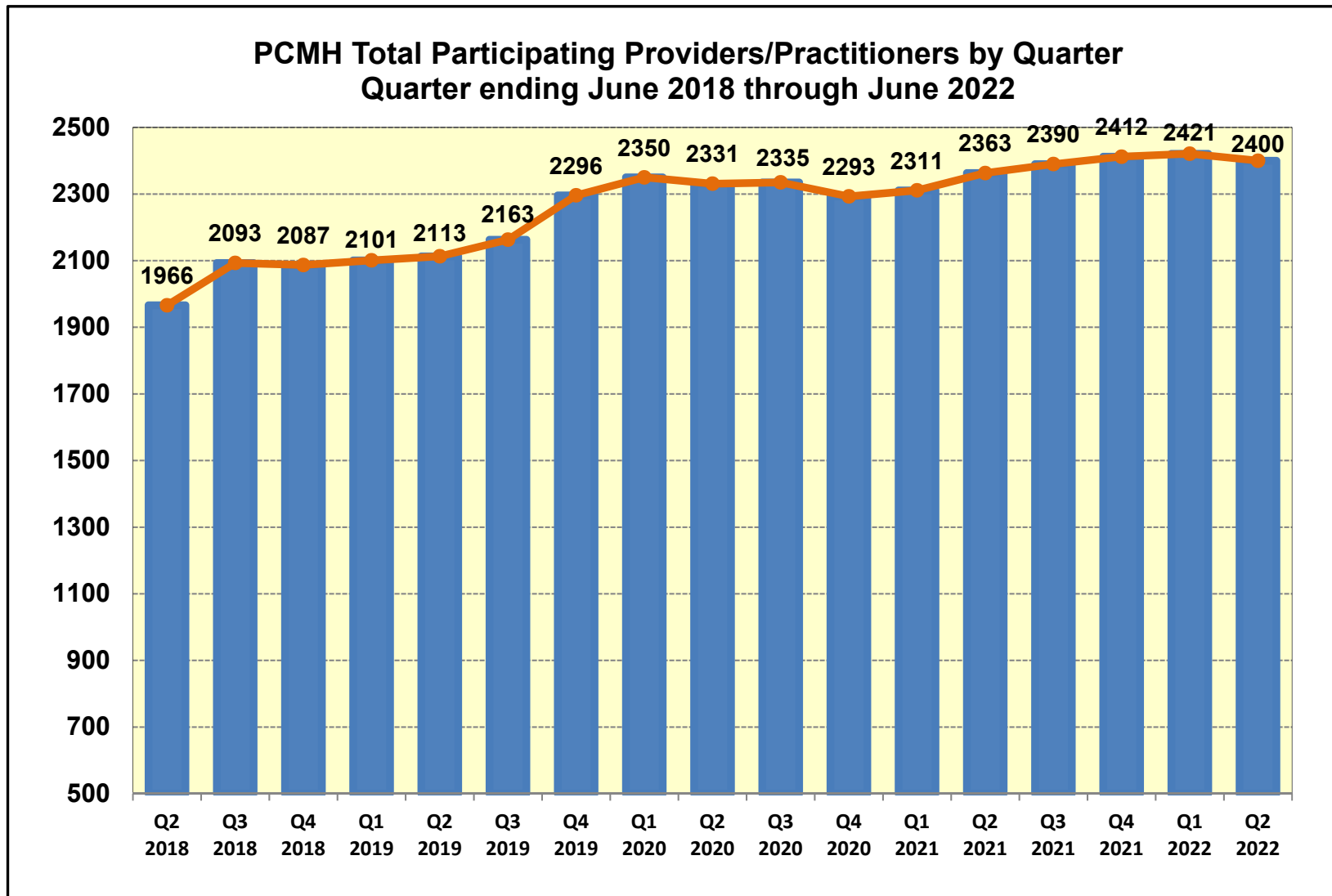
Provider Specialty by PCMH Program Participation as of June 30, 2022



PCMH Program Growth-Practices & Sites



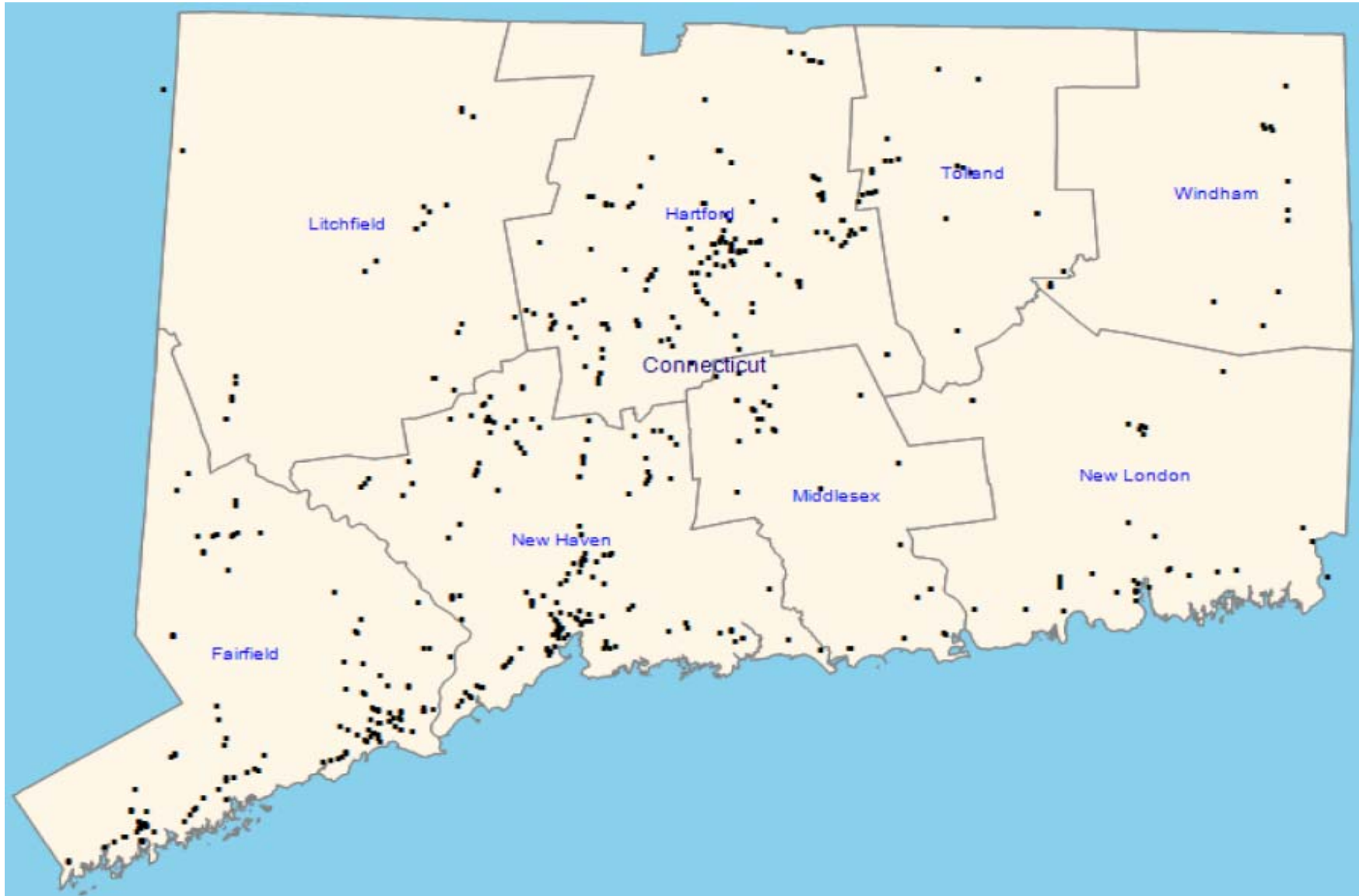
PCMH Program Growth - Providers





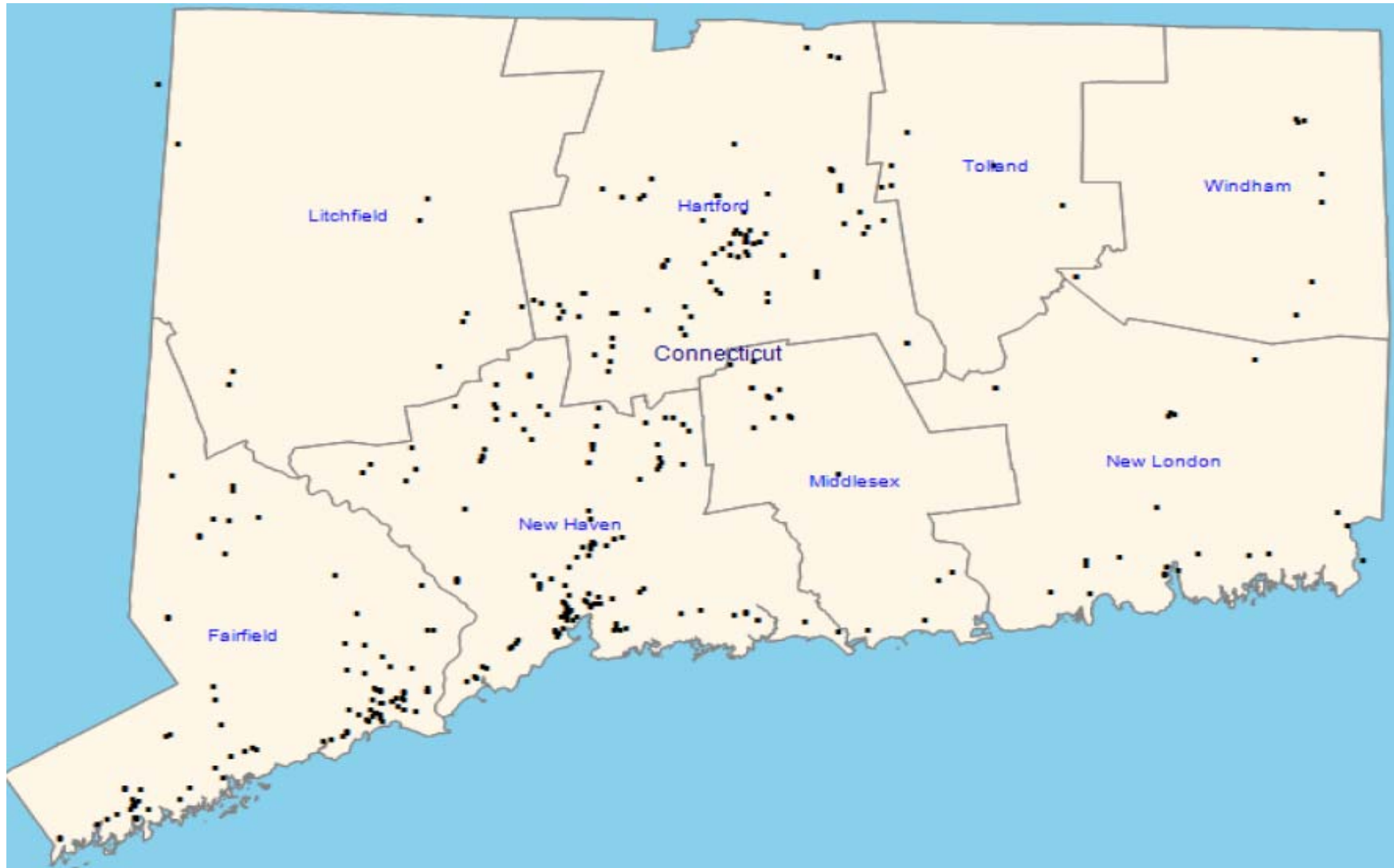
PCMH Practice Site Locations

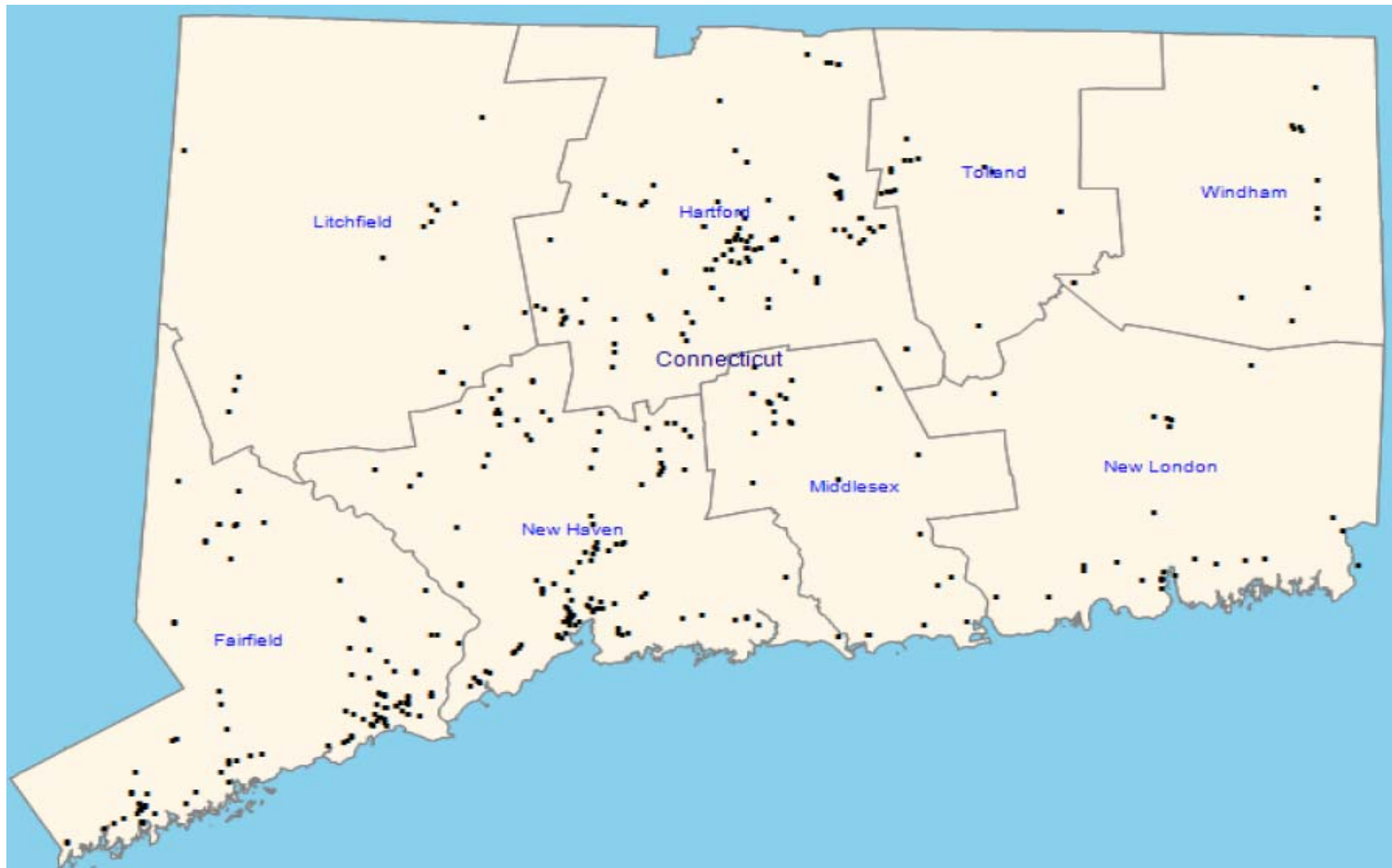
Internal Medicine PCMH Program Practice Site Locations

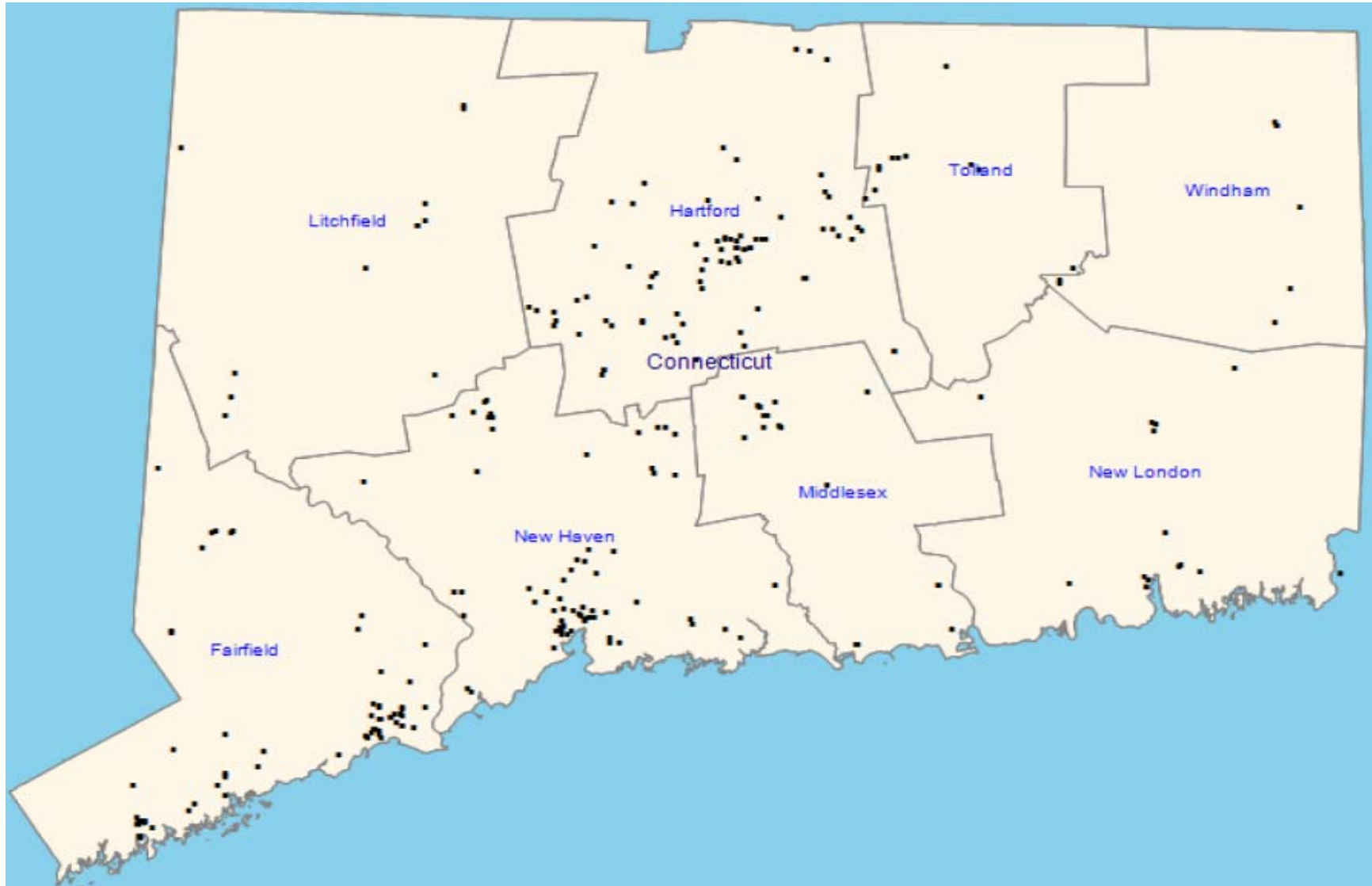
Family Practice PCMH Program
