Goals & Strategies	Provide committee members more opportunity to weigh in on the goals	
Scope	Expand the scope of work to encompass an overall Medicaid strategy, inclusive of community infrastructure to address HRSN	
Timeline	Extend the timeline for program design work; allow more time to engage, don't rush	
Data & Evidence	Spend more time orienting committee members to the prior work (i.e., program data & evidence)	
Records	Distribute meeting minutes and create a central repository for meeting materials	
FQHC Topics	Provide the FQHC subcommittee the opportunity to further discuss FQHC specific concerns (e.g., dental integration, VBP models of interest)	

Response

- Engaged in more discussion of the goals and provided clarifying definitions
- Reframed this work in the context of broader strategies to address HRSN; will be seeking input regarding broader strategies
- Revised timeline to target program launch as of January 2025, instead of July 2024
- Spent time with both committees reviewing and answering questions about data and evidence base

- Planning to use upcoming meeting of the FQHC subcommittee to engage in more discussion of FQHC specific concerns
