

I have written numerous letters, as many of you have seen, however, this one will be one you will remember because we are not ASKING anymore. We are DEMANDING our lives back. It's our God-given right under the Constitution of the USA under Amendment #14.... you know what it says so I am not going to waste the time. I can't believe it's 2022 and we are still allowing this tyranny to exist in our beautiful CONSTITUTION state.

Simply, stop the child abuse and stop robbing our kids of their education. More emails are coming and will be flooding all of your inboxes. Special thanks to all of you with the integrity to stand up for what's right for these families and especially our children. May their voices be heard all over the nation.

We moved to New Hartford primarily due to the amazing school system community and the country lifestyle. We are young and new homeowners. Now we are left with no virtual schooling option and no mask exemption, so we are forced to homeschool our child. Not only that, but I also lost my job as a teacher last fall due to Lamont's VAXX mandate. Now my husband has to work 3 jobs just to put food on the table. Our kids demand their public education and not the way it used to be either. Our kids have been robbed of their childhood, socialization, developmental needs as well as their public education. We now are demanding change in the education system. (I will be writing about this at a later time) Yes, we struggle to pay our mortgage and may be refinancing due to these past 2 years which were stolen from us against our will. Our tax dollars pay for this and we will not continue supporting this tyrannical government continuing to normalize this inhumane enslavement, indoctrination and attempts to silence our children. Every voice matters and I will testify for the children who remain wounded because of this mask insanity.

I will speak for the moms, dads and guardians who work their tails off to put food on the table and don't have the time or energy to come out and speak. I will be one of many voices who will continue speaking up for those who are weary and heavy-laden. Stop the mandates, or lose our support. The most powerful feedback given to me from last year was regarding a child I was working with who had autism diagnosis and the supervisor was very impressed with my patience. I took that as a complement and decided to teach others how to help autistic kids. I volunteer my time with various private families in need. I would like serve the community in most need of my experience as an educator for 15 years and my specialty in reading and writing. My number one priority is engage their intrinsic motivation to succeed. There are many different ways to achieve in the process but it takes time, energy and patience. It is important to work on training students to be engaged critical thinkers, joyful readers, optimistic thinkers while using creative processing. I believe

I left a Literacy Coach teaching job opportunities one month into the job because they were mandate PCR tests too frequently and the mask mandate was literally silencing kids. I saw it first hand!

I did eventually accept a teachers aide job but even that was difficult and I always found myself passing bringing kids to the nurse due to nasal allergies to the masks, irrational fears, rashes, dehydration, etc....It was HEARTBREAKING to watch.

To resist I would often pull my mask down and give a HUGE smile to the kids or toss someone a wink. "Mrs. Z, you don't have your mask on...". A child had said with a chuckle. I returned a simple whisper, "I'm not sick and neither are you." I am sure I am not alone in this "rebellion" of these toxic mandates, but I think it is important for the public to be aware of the needs of our children. The basic need of water, socialization, safety and a healthy laughter is medicine for the soul!

This particular child pulled her mask under her chin and I saw her smile for the first time despite the chin rash that bothered her daily and everyone just dismissed as "Attention Seeking" Don't misquote me, or twist my words, teachers tried to help, but many had their hands full and they were stretched beyond the usual degree. The nurses were in a more tremendous burn out. The need was imperative but they couldn't find a permanent nurse. Some days there was NO NURSE in the building and administrators were thrown into the arena. I'm not sure of exact number but I think this CREC school went through about 3 different nursing staff and a rotating handful of substitute nurses.

It was an extremely unstable environment in the realm of school nurse consistency and attentive care. It was a pivotal moment when I realized I really can make a difference "one starfish at a time"

Our daughter, Melody was in kindergarten at Bakerville School in New Hartford CT the whole year of 2020. She would come home with a dirty mask and even developed a nervous habit of biting her mask. She had trouble going to the bathroom at school due to anxiety so she would wait until she got home. After intense battles with BOE in

an attempt to demand our God-given & US Constitutional right to our daughter's education under Amendment #14, the BOE has still not compromised. My husband and I spoke up publicly asking that the schools provide, at the very least, a virtual option for school children who cannot wear masks for whatever reason (religious/medical/parent's right to choose). They rejected the proposal.

Therefore, two weeks into Melody's first-grade class, we pulled her out and decided to homeschool during this pandemic/ mask mandate. It is our full intent to send her back to school as soon as the mask mandate is lifted and on the terms that her religious exemption, which she had on file since preschool (2019), will be honored and that there be NO SEGREGATION of "unvaxxed" children.

Since we had to pull our daughter out of the public schools due to the corrupt violation of our human rights under Ned Lamont's "executive powers", we now have only ONE income, rather than the two teacher incomes we had in 2019. I am a libertarian but I am a registered republican and I DO NOT believe in big government welfare systems simply because they don't work and only enable laziness. I support helping the disabled and the veterans, but in MANY cases even these folks can be put to work! It's healthier for them and for sustainable economy. I can offer work for folks in need, but first I need to build up our business. My husband is now working three jobs and I am trying to navigate through online work but it has been three months and I finally finding work that would fit this lifestyle -as a homeschooling mom. I am now a freelance writer. I create lesson plans for teachers and I tutor kids who are struggling with reading/writing.

**\*2)** There are several of Dr Simone Gold's peers several doctors in the *Americas Frontline Doctors* group that have faced tremendous personal pushback, there's a man in Oregon who refused to wear one and refuses to force his staff to wear them, but you can wear one if you want to. The state of Oregon actually yanked his medical license. This was impossible to conceive of without *due process*, so AFD decided to help him file lawsuits.
