

Written Testimony for the 2/8/22 CTN Legislative Public Session Commentary

MY NAME IS SUSAN PATRICELLI REGAN AND I BELIEVE IN "WE THE PEOPLE" OF CT. WE, THE HARDWORKING TAXPAYERS HAVE BEEN MIS-LED BY NED. HE HAS PROVIDED DICTATORSHIP, RATHER THAN LEADERSHIP. THE ONEROUS ATTACK ON THE MOST VULNERABLE SEGMENTS OF OUR STATE'S CITIZENS - OUR YOUTH IN SCHOOLS AND SENIORS IN NURSING HOMES THROUGH HIS EXECUTIVE ORDERS LEAVES NOTHING TO HIS LEGACY EXCEPT BLOOD ON HIS HANDS. THE DEMOCRATIC MAJORITY BELIEVE THEY HAVE AVOIDED ANY BLAME FROM THEIR CONSTITUENTS FOR THE COLLATERAL DAMAGE OF LAMONT'S ONGOING UNILATERAL POWER. HOWEVER, THEY ARE ACCOMPLICES TO THE CRIME IN NOT DENYING HIS AUTOCRATIC STYLE.

ARE WE TO BELIEVE IN HIS PRESS CONFERENCE YESTERDAY, FEB. 7TH HE SAID HE WOULD DECLARE A MORATORIUM ON THE MASKING IN SCHOOLS AND LEAVE IT TO A TOWN BY TOWN DETERMINATION AS TO WHETHER TO CONTINUE THE MANDATE. HE OFFERS THE PROMISE OF PROPERTY TAX CREDITS, AGAIN HIS YESTERDAY'S PROMISE OF ADDRESSING THE ISSUE OF CRIME IN CT, AVOIDANCE OF TOLLS AND TCI FORMER THREATS BUT THAT IS ONLY A SHELL GAME AND TALK OF WHAT HE CAN ACCOMPLISH FOR INFRASTRUCTURE AND ENVIRONMENTAL IMPROVEMENT WITH A HEALTHY RAINY DAY FUND BALANCE. CT IS SAYING "FOOL ME ONCE SHAME ON YOU, FOOL ME TWICE SHAME ON ME" BUT THEY WILL RESPOND IN NOVEMBER 2022 BECAUSE CRT WILL BECOME "CRITICAL RATIONAL THINKING", NOT CRITICAL RACIAL THEORY.

WERE THE PEOPLE OF OUR STATE ABLE TO INITIATE A CLASS ACTION SUIT AGAINST THE ADMINISTRATION AND THE DEMOCRATIC MAJORITY FOR THE INJURIOUS CONSEQUENCES OF THE PAST TWO YEARS TO THE CT CITIZENS, YOU WOULD FIND MANY INDEPENDENTS AND ACROSS THE AISLE VOTERS WHO WOULD SIGN THE PETITION TO DO SO.
