The contract between Yale University (the "Contractor") and the Connecticut Department of Mental Health and Addiction Services (the "Department" or "Agency"), which was last executed by the parties on effective date: 9/1/15 is hereby amended as follows:

- 1. <u>Maximum Contract Amount:</u> The total maximum amount payable under this contract is increased by \$56,000 from \$18,156,388 to \$18,212,388.
 - Funding is added to increase staffing allocated to the Alternative Drug Intervention and Women's Jail Diversion Programs, per the contractor's Staffing Plan and Line Item Budget, submitted to and approved by the Department.

All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.
